First Aid Policy

Governor Oversight: Finance and General Purposes

This policy has been authorised by the Governors of Exeter Cathedral School. It is available to parents and pupils and to all members of School Staff via the School website.

This policy should be read in conjunction with Prescription and Non-Prescription Medication / First Aid Procedures / Administration of Medicine (including EYFS) / Administration of Medicine Policy in the EYFS.

This policy has been written with regard to the DfE Guidance on First Aid, the ISI Handbook for the inspection of association independent schools, including residential (boarding) schools and registered early year settings and with regard to the DfE Guidance, as referenced in the Early Years Foundation Stage Statutory Framework for group and school-based providers (effective January 2024).

This Policy applies to all children at Exeter Cathedral School, including those in EYFS.

Definitions

First Aid means the treatment of minor injuries which do not need treatment by a medical practitioner or nurse aswell as treatment of more serious injuries prior to assistance from a medical practitioner or nurse for the purpose of preserving life and minimising the consequences of injury or illness. For the avoidance of doubt, First Aid does not include giving any tablets or medicines, please refer to the Administering Medicines Policy.

Staff means any person employed by the School, volunteers at the School and self-employed people working on the premises.

First Aiders are members of staff who have completed a Health and Safety Executive (**HSE**) approved First Aidcourse and hold a valid certificate of competence in First Aid at Work (**FAW**), Emergency First Aid at Work (**EFAW**)or specifically for the provision of EYFS children in Paediatric First Aid.

Aims of this Policy

To ensure that the School has adequate, safe and effective First Aid provision in order for every pupil, member ofstaff and visitor to be well looked after in the event of any illness, accident or injury, no matter how major or minor.

To ensure that all staff and pupils are aware of the procedures in the event of any illness, accident or injury.

Nothing in this policy should affect the ability of any person to contact the emergency services in the event of amedical emergency. For the avoidance of doubt, Staff should dial 999 for the emergency services in the event of amedical emergency before implementing the terms of this Policy and make clear arrangements for liaison with ambulance services on the School site.

Who is responsible?

The Governors of Exeter Cathedral School, as the employer, have overall responsibility for:-

- Ensuring that the School has adequate and appropriate First Aid equipment, facilities and First-Aid personnel and for ensuring that the correct First Aid procedures are followed.
- Ensuring that suitable and sufficient risk assessments of the health and safety of employees, pupils and visitors to the School are carried and for identifying the measures taken for controlling those risks.

The Director of Finance & Operations is responsible for ensuring that all staff and pupils (including those withreading and language difficulties) are aware of, and have access to, this policy.

The School Nurse is responsible for ensuring that the School has sufficient First Aid personnel.

The School Nurse is responsible for ensuring that there is adequate and appropriate First Aid equipment and facilities.

The School Nurse is responsible for ensuring that First Aid personnel have up to date training.

The Headmaster delegates to the School Nurse, in liaison with the Admissions & Marketing Manager and the Receptionist & Database Manager, responsibility for collating medical consent forms and important medical information for each pupil and ensuring the forms and information are accessible to staff as necessary.

First Aiders

The list of qualified first aiders and paediatric first aiders can be found on display in the Prep school staff room and the Hall House staff room.

The main duties of First Aiders are to give immediate First Aid to pupils, staff or visitors when needed and to ensure that an ambulance or other professional medical help is called when necessary. First Aiders are to ensure that their First Aid certificates are kept up to date through liaison with the School Nurse and Director of Finance & Operations.

The First Aiders will undergo update training at least every three years.

All staff should read and be aware of this Policy, know who to contact in the event of any illness, accident or injury and ensure this Policy is followed in relation to the administration of First Aid. All staff will use their best endeavours, at all times, to secure the welfare of the pupils.

It is our policy that there will be at least one qualified person on site during normal school hours and on trips.

First Aid Boxes / Emergency Boxes

First Aid boxes are marked with a white cross on a green background and are stocked by the School Nurse. FirstAid boxes are to be inspected by the School Nurse half termly. If items are used the School Nurse should be informed so that the relevant box can be restocked. The contents of first aid boxes is in accordance with the guidance given in HSE document "Basic advice on first aid at work" INDG 347.

First aid boxes are located at these positions around the site and are as near to hand washing facilities as is practicable:-

The Chantry – main reception, playground, kitchen and the School Nurse's room
Evans Building – science laboratory
Coach House – food Technology room
Kalendar Hall – front hall
Hall House – Reception
Nursery – kitchenette
School minibuses

In addition, there are emergency asthma, diabetic and EpiPens located in:

- Hall House reception
- The Chantry
- Chapman/Evans
- Kalandar Hall.

School Vehicles

The School minibuses all have a prominently marked First Aid box on board which is readily available for use and which is maintained in a good condition. All sports teachers have their own sports FA bags. First Aid kits must betaken when groups of pupils go out of school on organised trips or to participate in sports which can be obtained from the School Nurse.

Automated External Defibrillator (AED)

The School has a portable AED available for use, should it be required. This is stored in the Reception of the Chantry and these devices can be used safely by anyone without training. This device is also available to take to sports fixtures and events off site.

There is an AED located outside the entrance of Chapman for both public and school use.

Information on Pupils

Parents are requested to provide written consent for the administration of First Aid and medical treatment beforepupils are admitted to the School.

The School Nurse will be responsible for reviewing pupils' confidential medical records and providing essentialmedical information regarding allergies, recent accidents or illnesses, or other medical conditions which may affect a pupil's functioning at the School to the Headmaster, class teachers and First Aiders on a "need to know" basis. This information should be kept confidential but may be disclosed to the relevant professionals if it is necessary to safeguard or promote the welfare of a pupil.

Medical records for all pupils in Pre-Prep and the Prep are stored on the School's MIS. This information includes medical consent forms, records of any medication or first aid that can or cannot be given and records of all accidents and injuries.

Information held by the School Office will include a record of pupils who need to have access to asthma inhalers, EpiPens, injections or similar and this information should be circulated to teachers and First Aiders.

Dealing with Pupils with Allergies

Information about pupils with allergies is provided to all teachers and First Aiders. Details of pupils who have been prescribed EpiPens to use in instances of allergic reaction are included in this information. All staff have receivedtraining on the use of EpiPens and should be aware of the location of spare EpiPens for specific pupils.

Individual pupils (or their form teachers as appropriate) usually have responsibility for keeping such equipment i.e. inhalers. All other pupils' own EpiPens will be kept in the Chantry Reception desk (bottom drawer), Hall House Reception desk (top drawer) and Nursery cupboard in the kitchen. These areas all have a green first aid sign.

Procedure in the event of illness

If a pupil feels unwell the school uses a Triage tool to determine the level of seriousness. For example can the child wait until break/lunch to be seen by the School Nurse? The Pre-Prep Receptionist is the first point of call in the Pre-Prep, and the School Nurse is called if required.

If a pupil becomes ill during the day, the School will contact the parents so that the child can be collected if required.

If a child cannot be collected immediately and is too unwell to wait in the Hall House Reception, the Library or the School Nurse's room, there is access to the School treatment room which is managed by the School Nurse.

The School Nurse is on duty from 08h00 - 17h00 Tuesday to Thursday and will administer first aid and deal with accidents andemergencies or when someone is taken ill. Outside of these hours a qualified first aider will be able to attend to the child. The School has many qualified first-aiders, including Paediatric First Aiders, spread across the site.

Procedure in the event of an accident

If an accident occurs, then the member of staff in charge should be consulted. That person will assess the situation and decide on the next course of action, which may involve calling immediately for an ambulance. First Aiders can also be called for if necessary.

In the event that the First Aider does not consider that they can adequately deal with the presenting condition by the administration of First Aid, then they should arrange for the injured person to access appropriate medical treatment without delay.

If an ambulance is called, then the First Aider in charge should make arrangements for the ambulance to have access to the accident site. Arrangements should be made to ensure that any pupil or adult is accompanied in the ambulance if necessary, or followed to hospital, by a member of staff if it is not possible to contact the parents in time.

The member of staff should inform the Director of Finance & Operations and Headmaster as soon as practically possible.

Procedure in the event of contact with blood or other bodily fluids

If a spillage of blood or other bodily fluids occurs, the Cleaning Team/Maintenance Team and School Nurse is informed. They will then arrange for the proper containment, clear up and cleansing of the spillage site

The First Aider should take the following precautions to avoid risk of infection:

- cover any cuts and grazes on their own skin with a waterproof dressing;
- wear suitable disposable gloves when dealing with blood or other bodily fluids;
- use suitable eye protection and a disposable apron where splashing may occur;
- and, wash hands after every procedure.

If the First Aider suspects that they or any other person may have been contaminated with blood and other

bodilyfluids which are not their own, the following actions should be taken without delay:

- wash splashes off skin with soap and running water;
- wash splashes out of eyes with tap water or an eye wash bottle;
- wash splashes out of nose or mouth with tap water, taking care not to swallow the water;
- record details of the contamination;
- and, report the incident to the School Nurse and take medical advice if appropriate.

Procedure in the event of off-site accident, injury or illness

A First Aid kit obtained from the School Nurse or from the Hall House Medical cupboard should be carried by all teachers in charge of off-site activities. A medical report, including a list of pupils with allergies, will be part of the First Aid kit. Any treatment or incident should be documented on an accident book report: time/date and detailed description, give white copy to parent, yellow copy to Nurse. Call parent to inform if head injury or something more serious.

Leaders of School trips must ensure that First Aid provision is appropriate to the activities and groups concerned.

In line with Early Years Foundation Stage (EYFS) requirements, at least one person on the premises and one person on outings must have a paediatric first aid certificate.

Head Injuries

Children frequently sustain minor head injuries, but it is nonetheless important that procedures are in place for reporting any head injury, and that there is clear understanding of what signs/symptoms should be looked for in children who have hit their head whilst at school.

Following a head injury, the School Nurse will be called and will fully assess for any possible signs/symptoms of concussion and signpost the parent and child to the relevant department dependent on the severity of the presenting symptoms i.e. AE or GP. In the event the child is away on a fixture a paediatric first aider will assess.

Parents will be contacted to make them aware if a pupil has sustained a significant head injury or if any mark, bump, or cut has been caused by the injury. If after a head injury a pupil remains unconscious or fits, an ambulance should be called immediately, and the parents contacted.

Signs / symptoms to look out for:

- Loss of consciousness
- Repeated vomiting
- Sleepiness
- Fits or abnormal limb movements
- Persisting dizziness or difficulty walking
- Strange behaviour or confused speech
- A headache not eased by paracetamol

If a pupil sustains a head injury and concussion is suspected, the Graduated Return to Play programme will be initiated which is widely used by the The Rugby Football Union RFU (RFU). A doctor should examine all cases of suspected concussion. If concussion is diagnosed, the pupil will be 'off games' for a minimum of 14 days.

Dealing with Pupils with Asthma

Older pupils carry inhalers with them and use them as necessary. Younger children's inhalers are looked after by amember of staff and made available as necessary. Parents are asked to provide school with a spare inhaler. These are stored by the School Nurse.

Dealing with Pupils with Epilepsy

At the time of writing (September 2024), there is one pupil with epilepsy at ECS. The pupil has a plan in place, which is overseen and communicated by the School Nurse. Should any pupil suffer a fit or seizure, the School Nurse should be called for without delay.

Individual Pupils Healthcare Plans

All Pupils will have an Individual Healthcare Plan kept on file by the School Nurse. The School Nurse emails out to all parents in the summer term yearly to start the new academic year in September.

Pupils with medical conditions

Any pupils with medical conditions (e.g. asthma, epilepsy, diabetes, allergies, dietary requirements), the School Nurse will inform all members of staff which will remain confidential and only given out in an emergency situation for example if an ambulance was called.

Pupils with Diabetes

At the time of writing (September 2024) there is one pupil with Type 1 diabetes at the School. Pupils with diabetes should have a snack/glucose tablet in their bag to treat hypoglycaemia and a glucometer. Pupils with diabetes at the school will follow the care plan written by the diabetic nurse from the hospital/community setting and will be implemented at the school. Training is provided for relevant staff by the Diabetic Nurse Specialist.

Training

The school nurse ensures that staff have regular updates on the use of EpiPens and other emergency medication.

Controlled Medication/prescribed medication: for example, (ADHD medication).

This medication needs to be count in by the parent of the pupil and a member of staff, double signed in using the controlled medication book and stocked in our controlled medication cabinet. The medication should come in the original packaging, sealed, pupils name clearly labelled, furthermore the script should be brought in and the member of staff will photocopy and keep with the medication. If the medication isn't counted in and there was a discrepancy in the amount of tablets the police would need to be called this is due to it being a controlled medication.

Reporting

Onsite all injuries/illnesses (minor or major) are recorded on the School's MIS, and an email sent home or a phone call if a very serious injury or head injury. If the child has needed treatment offsite (for example AE/Minor Injuries Unit) this will be documented in the accident book, the white copy being given to Parent.

Reporting to Parents/Guardians

In the event of accident or injury sustained, parents must be informed on the same day or as soon as reasonably practicable, and of any first aid given. The member of staff in charge at the time will decide how and when this information should be communicated, in consultation with the Headmaster if necessary.

The school follows the NHS Choices guidelines for children being too ill to attend school, details can be found on the NHS Choiceswebsite: http://www.nhs.uk/Livewell/Yourchildatschool/Pages/Illness.aspx i.e. in cases of vomiting and diarrhoea children should definitely be kept off school until at least 48 hours after their symptoms have gone.

Reporting to HSE

The School is legally required under the Reporting of Injuries, Diseases and Dangerous Occurrences Regulations1995 (SI 1995/3163) (RIDDOR) to report the following to the HSE (most easily done on

line at http://www.hse.gov.uk/riddor/report.htm or by calling the Incident Contact Centre (ICC) on 0345 300 9923)

Accidents involving staff

Work-related accidents resulting in death or major injury (including as a result of physical violence) must be reported immediately to the Director of Finance & Operations (major injury examples: dislocation of hip, knee or shoulder; amputation; loss of sight; fracture other than to fingers, toes or thumbs). Work related accidents which prevent the injured person from continuing with his/her normal work for more than three days must be reported within 10 days. Cases of work-related diseases that a doctor notifies the School of (for example, certain poisonings; lung diseases; infections such as tuberculosis or hepatitis; occupational cancer). Certain dangerous occurrences (near misses - reportable examples: bursting of closed pipes; electrical short circuit causing fire; accidental release of any substance that may cause injury to health).

Accidents involving pupils or visitors Accidents where the person is killed or is taken from the site of the accident to hospital and where the accident arises out of or in connection with:

- any School activity (on or off the premises);
- the way a School activity has been organised or managed (e.g. the supervision of a field trip);
- equipment, machinery or substances;
- and, the design or condition of the premises.

Monitoring

The Headmaster and Director of Finance & Operations in conjunction with the School Nurse will organise an annual review of the School Accident and Illness Book and will, if necessary make recommendations to the School Governors. In addition, the Headmaster and Director of Finance & Operations will undertake a review of all procedures following any major incident to check whether the procedures were sufficiently robust to deal with the major occurrence or whether improvements should be made.
